Training Courses leading to Equivalent Academic Qualifications for Technically Competent Persons (TCP) T1 to T3 and Authorized Signatory of Contractors for Registration under the Buildings Ordinance

Since 2009, the Hong Kong Institute of Construction (HKIC) (formerly known as the Construction Industry Council Training Academy) and the Hong Kong Institute of Vocational Education (IVE) have been providing specially designed training courses, namely "Technically Competent Person T1 Training Course", "Professional Diploma in Construction Site Supervision" and "Professional Diploma in Construction Engineering". These courses are for site supervisory personnel who do not possess the academic qualifications as specified by the Technical Memorandum for Supervision Plans 2009 (TM) to attend. Upon completing the said courses, the site supervisory personnel can obtain the academic qualifications equivalent to those required by TCP T1, T2 and T3 (as applicable) of various streams under the TM. Among them, the course named "Professional Diploma in Construction Engineering" has also been recognised as an acceptable academic qualification of an authorized signatory (AS) of a general building contractor or a registered specialist contractor in the category of demolition works, foundation works, ground investigation field works or site formation works for the purpose of registration under the Buildings Ordinance.

Site supervisory personnel who wish to take up the role as a TCP T1, T2 and T3 or AS of a registered contractor but do not possess the related academic qualifications under the TM or Practice Note for Registered Contractors 38 respectively may consider applying for the above courses.
